





Wall Down Light 240V GU10 fitting shown in instruction sheet diagrams. Same installation procedure is applicable for all models listed on front cover of booklet.


FITTING KIT - PARTS SUMMARY

INSTALLATION - TIMBER WALL






FITTING INSTALLATION INSTRUCTIONS



- Loosen two Grub Screws on Fitting Base using Hex Tool (supplied) (A).
- Carefully remove Base Plate from fitting assembly (B).



- Carefully pierce central rubber Cable Grommet to create hole for cable entry (A).
- Position Base Plate in desired location on wall and use as template to mark locations of two mount holes (B).




For Timber walls:


Drill two pilot holes at marked locations to prevent timber splitting (A).

For Masonry walls:

- Drill two Ø5.5mm holes at marked locations (A).
- Insert two Masonry Wall Plugs (B) (supplied) into holes until ends are flush with wall surface.




- Apply a generous, continuous bead of silicone within rear recess on Base Plate (A).
- Failure to seal Base Plate will void warranty.




To mount Base Plate to wall:

- Align Base Plate with Masonry Wall Plugs or pilot holes.
- Fasten to wall with two Mounting Screws (supplied) (A).
- Clean-up any excess silicone around Base Plate.



- Licensed Electrical Contractor to connect fitting meeting all regulatory requirements.
- Coil cabling neatly into Fitting Base. Care must be taken to avoid cable damage.
- Assemble fitting to Base Plate (A).


NOTE – ADJUSTABLE MODELS* Ensure fitting is correctly oriented for desired range of movement.



 Attach fitting assembly to Base Plate by tightening two Grub Screws using Hex Tool (supplied) (A).



FITTING INSTALLATION INSTRUCTIONS



To prepare for Lamp installation:

 Carefully unscrew Len Housing/s and remove from Fitting Body (A).



Lamp installation:

- Insert LED GU10 Lamp/s** into Lamp Holder/s inside fitting assembly (A).
- Re-attach Lens Housing/s to Fitting Body (B). Care must be taken when assembling Lens Housing to prevent thread or seal damage. Hand tighten until seal is fully compressed.
- ADJUSTABLE MODELS* Rotate and position Fitting Body to light desired area.

WARRANTY STATEMENT

Serrata Group Pty Ltd warrants that, subject to the exclusions and limitations below, all Gardens at Night products will be free from defects in materials and workmanship for a minimum period of 12 months from the date of purchase or as stated on the Product Information sheet.

If a defect appears in a Product before the end of the Warranty Period, and Serrata Group Pty Ltd finds the Product to be defective in materials or workmanship, Serrata Group Pty Ltd will, in its sole discretion, either:

- (a) repair the Product or the defective part of the Product free of charge; or
- (b) cause the Product or the defective part of the Product to be repaired by a qualified repairer free of charge; or
- (c) replace the Product.

Serrata Group Pty Ltd reserves the right to replace defective parts of the Products with parts and components of similar quality, grade and composition where an identical part or component is not available. Products presented for repair may be replaced by refurbished Product parts of the same type rather than being repaired. Refurbished parts may be used to repair the Products.

WARRANTY CLAIMS

- If a fault covered by this warranty occurs, the customer must first contact Serrata Group Pty Ltd on the contact details below, or the trader from whom the Product was purchased.
- 2. Any warranty claim must be accompanied by:
 - (a) proof of purchase;
 - (b) full details of the alleged defect; and
 - (c) any other appropriate documentation.
- The customer must make the Product available to Serrata Group Pty Ltd or its authorised repair agent for inspection and testing. If such inspection and testing finds no defect in the Product, the customer must pay Serrata Group Pty Ltd's usual costs of service work and testing.
- The customer must bear the cost of the transport of the Product to and from Serrata Group Pty Ltd or its authorised repair agent, and all insurance of the Product.

- customer's failure to properly use, service or maintain the Product in accordance with any instructions or user manuals that are supplied with the Product; (f) the Product has been subject to abnormal conditions,
- the Product has been subject to abnormal conditions including environment, temperature, water, fire, humidity or similar;

(e) the defect in the Product has arisen due to the

- (g) the defect has arisen due to abuse, misuse, neglect or accident
- (h) the damage occurred in transit;
- (i) the damage is due to power surges.

The warranty does not extend to:

- (a) damage or defects caused by normal wear and tear;
- (b) surface rust.

You are entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure.
